

**TERMS AND CONDITIONS OF PARTICIPATION IN THE QUESTIONNAIRE
FOR VISITORS TO THE EXHIBITION BULMEDICA / BULDENTAL 2018:**

1. The questionnaire for visitors to the exhibition BULMEDICA / BULDENTAL 2018 (five vouchers, each of them worth BGN 2,000, for equipment, materials, supplies and other products in the field of medicine and dentistry) is organized by Inter Expo Center Ltd., UIC 121122275 with registered office and address at: Sofia, 147 Tsarigradsko shose Blvd, represented by Ivaylo Ivanov – General Manager.
2. The questionnaire will be launched on May 16, 2018 at 9:30 am, and will be closed on 18 May, 2018 at 3:45 pm.
3. Right to participate in the questionnaire shall be granted to every visitor of the specialized medical exhibition BULMEDICA/BULDENTAL 2018 who is an individual of legal age and full capacity /Respondent/, **having the right to practice a medical profession or being an employee of a health care establishment** and having filled in completely and accurately the questionnaire. The questionnaire cards shall be dropped in specially prepared boxes in the exhibition complex Inter Expo and the Congress Center in Sofia, 147 Tsarigradsko shose Blvd.
4. The questionnaire card is free of charge and the awards shall have only advertising purposes.
5. Partially or illegibly completed questionnaire cards shall not participate in the draw of the vouchers.
6. More than one questionnaire card completed by one and the same person shall result in cancellation of his participation.
7. The voucher provides the winning participant with the right to choose a product/s and/or service/s at the amount of value indicated on the voucher, from the companies participating in the exhibition Bulmedica / Buldental 2018 – limited to not more than three companies, Bulgarian legal entities.
8. If the value of the selected product/s and/or service/ s is higher than the voucher value, the difference shall be paid by the winning person.
9. The voucher shall only be valid once for the winning person.
10. The voucher shall not be subject to return or change.
11. The voucher cannot be redeemed.
12. The award voucher is valid until October 1, 2018.
13. The drawing of winning questionnaire cards (and reserve cards - one for each voucher) will be held on May 18, 2018 at 4:00 pm in the foyer of the exhibition complex Inter Expo Center and the Congress Center in the presence of a lawyer.
14. The voucher can be obtained within 30 calendar days from the date the winning person has been notified. Failure of the voucher winning person to appear within the period mentioned in the preceding sentence, the voucher shall be given to the drawn up reserve candidate.
15. The voucher is obtained against presentation of a work certificate or a card, certifying the eligibility of participants in the questionnaire game to exercise medical profession and an identity document.
16. Respondents who are **employees of a health care establishment** must, upon receipt of the voucher, provide proof of current employment, position, and identity by means of relevant credentials and documents.
17. Representatives of the organizers of the exhibition, their family members, exhibitors and minors shall not be entitled to take part in the questionnaire game.
18. The organizers shall not be held liable for duties and taxes owed by the winning participants.
19. By completing the leaflet, the participant gives his / her consent and declares that:
 - 19.1. provides the Organizer (the personal data administrator referred to in Article 19 (1) of the LPPD) voluntary and willingly information about himself, that represents personal data within the meaning of the LPPD (three names, valid e-mail address).

19.2. the personal data provided by him can be processed by the Organizer for the purposes of the campaign.

20. The Organizer informs the participant that:

20.1. personal data are collected for a specific purpose - participation in the draw within the Bulmedica / Buldental 2018 exhibitions, they are processed legally and in good faith and cannot be further processed in a way incompatible with that purpose;

20.2. personal data are stored on paper and / or electronic media only for the time required to achieve the objectives of the campaign;

20.3. after the purpose of processing the participant's personal data has been achieved, the information contained in the completed leaflet should be destroyed in a way that prevents data recovery and misuse.

21. By receiving the vouchers, the winner of the present questionnaire agrees to give further, explicit written consent that the names (name and surname) and his / her picture to become public and to be used on the official website of the Organizer, where no payment is due by the poll Organizer. Any other data that has become known to the Organizer in connection with winning the vouchers cannot be disclosed.

22. The Organizer shall not be held responsible for the protection of personal data submitted in addition by the winning participant in accordance with paragraph 21 of these Terms and Conditions, namely: (his photograph, name and surname published on the website of the Organizer).
